# Board of Supervisors Meeting Minutes April 9, 2014

The Regular Meeting of the Lower Oxford Township Board of Supervisors was held at the Township Building, 220 Township Road, on Wednesday, April 9, 2014.

<u>The following were in Attendance:</u> Chairman Kenneth L. Hershey, Vice Chairman W. Ronald Kepler, Supervisor Joel C. Brown, Codes Enforcement Officer Deborah Kinney, Secretary/Treasurer Sara Laganelli, and three guests. Building Inspector Scott Moran and Roadmaster Steve Price were absent.

#### CALL TO ORDER

Chairman Kenneth L. Hershey called the meeting to order at 7:00 p.m.

## PLEDGE OF ALLEGIANCE & MOMENT OF SILENCE

Mr. Kenneth L. Hershey led the Pledge of Allegiance to the flag and asked for a moment of silence.

## RECOGNITION OF THOSE ASKING TO APPEAR ON THE AGENDA

**Larry Maulo, CPA** – Mr. Maulo reported that he had finished conducting the 2013 Audit. He presented the Supervisors with a draft Financial Audit Report that would be filed with DCED. The Township is in the black and had a positive audit. The internal controls are very good. The Supervisors oversee everything closely. There were no management recommendations.

Mr. Kepler moved to accept the audit report. Mr. Brown seconded the motion. MOTION CARRIED.

## APPROVAL OF THE MINUTES

Mr. Brown moved to approve the minutes for the regular meeting on March 12th. Mr. Kepler seconded the motion. MOTION CARRIED.

#### TREASURER'S REPORTS

**Presentation of Bills** – Mr. Kepler moved to approve and pay the bills: totaling \$49,085.83 for General Fund, \$15,604.50 for Open Space Revenue Fund (including settlement for McCummings), and \$514.54 for the Sewer Fund. Mr. Brown seconded the motion. MOTION CARRIED.

Mr. Hershey noted that he attended the PUC Hearing in Penn Township. There were two main issues: communications and lack of tree maintenance.

Mr. Hershey will attend the Fire Company meeting. Lower Oxford is not in favor of raising the millage. Mr. Kepler moved to accept the correspondence. Mr. Brown seconded the motion. MOTION CARRIED.

#### **BUILDING INSPECTOR**

The Secretary read the Building Inspector's report. There were two plan reviews and five regular inspections for the month of March. Mr. Brown moved to approve the Building Inspector's Report. Mr. Kepler seconded the motion. MOTION CARRIED.

## **CODES ENFORCEMENT OFFICER**

Mrs. Kinney read the Building Permits & Zoning Violations Reports for March. She issued three residential building permits and had one zoning violation for chickens at 176 Hall Rd.

Mr. Kepler moved to adopt Resolution 2014-12 for a six month extension to the Reedville Ventures final plan approval. Mr. Brown seconded the motion. MOTION CARRIED.

Mr. Kepler moved to approve the Codes Enforcement Officer's reports. Mr. Brown seconded the motion. MOTION CARRIED.

## **ENGINEER**

The Secretary read the Engineer's report for March. Mr. Kepler moved to approve the Engineer's report. Mr. Brown seconded the motion. MOTION CARRIED.

#### OASA Report

Mr. Bob Yeatman reported that there is progress being made on the new treatment plant. The Ross Spray fields will be online soon. There is still seeding that needs to be done. The contractor is finished. Mr. Kepler moved to approve Mr. Yeatman's report. Mr. Brown seconded the motion. MOTION CARRIED.

#### <u>ROADMASTER</u>

The Secretary read the Roadmaster's Report for March. She also noted that the road expenses totaled more than \$32,500.00 for this winter's snow removal. PennDOT said that there should be a "severe weather adjustment" coming to the Township sometime before the end of June. Mr. Brown moved to approve the Roadmaster's Report. Mr. Hershey seconded the motion. MOTION CARRIED.

Mr. Kepler moved to authorize the Secretary to advertise the bids for the 2014 Township Road projects to be opened at the May 14<sup>th</sup> meeting. Mr. Brown seconded the motion. MOTION CARRIED.

## **REGIONAL RECREATIONAL AUTHORITY**

#### **HISTORICAL COMMISSION**

Mr. Jay Eaton reported that on February 25<sup>th</sup> they hosted a tour at the University and Village of Lincoln. They are helping the Lincoln University Historic Initiative section the campus and village historic buildings. There may be some buildings that qualify for the National Registry. The Historic Initiative is taking the lead and submitting an application for a Keystone Grant. Mr. Kepler moved to approve the Historic Commission report. Mr. Brown seconded the motion. MOTION CARRIED.

## OXFORD REGIONAL PLANNING COMMITTEE

Mr. Brown reported that the March meeting had been postponed. The next meeting is April 23<sup>rd</sup>, where they will discuss the zoning map change for the Lincoln University KOZ. Mr. Kepler moved to approve the report. Mr. Hershey seconded the motion. MOTION CARRIED.

#### **OLD BUSINESS**

Open Space Preservation - Settlement for Shawn McCummings has been scheduled for April 17th.

Lincoln Village Sewer Delinquent Accounts – The Secretary reported that Cosme Alvarez, 264 Ashmun Ave., owes \$1,501.19 to the Township for sewer tapping fees and has not made any payments since October 2013. Mr. Kepler moved to send this account to collections. Mr. Brown seconded the motion. MOTION CARRIED.

# OASA Fulton Bank Bridge Loan – As per the Township Solicitor:

Mr. Kepler moved to vacate Resolution 2014-08 adopted at the February 12<sup>th</sup> meeting. Mr. Brown seconded the motion. MOTION CARRIED.

Mr. Kepler moved to adopt Resolution 2014-10 for the approval of the Oxford Area Sewer Authority's Fulton Bank Bridge Loan in the amount of \$18,500,000. Mr. Brown seconded the motion. MOTION CARRIED.

## OTHER BUSINESS

**Burning Plastic** – Mr. Hershey said that there have been complaints about people burning plastic. Mrs. Kinney said she contacted DEP and residential household plastic is okay to burn; commercial type plastic is not. Mr. Brown asked about Ag Waste; for example, bags for silage and hay or greenhouse plastics. Mr. Kepler will contact SECCRA to see if these plastics are recyclable.

#### PUBLIC COMMENTS

Mr. Jay Eaton – Asked if there would be sewer issues with the Lincoln University KOZ.

Mr. Kepler thanked everyone for attending and moved to adjourn the meeting at 8:06 p.m. Mr. Brown seconded the motion. MOTION CARRIED.
