Chairman Kenneth L. Hershey called the meeting to order at 7:00 p.m.

APPROVAL OF THE MINUTES

Mr. Kepler moved to approve the minutes for the regular meeting and zoning hearing on March 9, 2016. Mr. Brown seconded the motion. MOTION CARRIED.

CODES ENFORCEMENT OFFICER

Mrs. Kinney read the Building Permits & Zoning Violations Reports for March. She issued two residential building permits, three commercial permits, and one Use & Occupancy permit. There was a violation at 552 Union School Rd. for building a high tunnel without a permit. Collision Zone still did not replace the privacy fence but says they will comply by the end of May.

Mr. Kepler moved to approve the Codes Enforcement Officer's reports. Mr. Brown seconded the motion. MOTION CARRIED.

The Secretary read the Roadmaster's Report for March. Mr. Kepler moved to approve the Roadmaster's Report. Mr. Brown seconded the motion. MOTION CARRIED.

HISTORICAL COMMISSION

The Secretary read the Historic Commission's report in Mr. Jay Eaton's absence. Mr. Kepler moved to approve the report. Mr. Brown seconded the motion. MOTION CARRIED.

EMERGENCY MANAGEMENT

Mr. Kepler reported that the Township had filed the paperwork for snow assistance from FEMA for the blizzard. Mr. Brown moved to adopt Resolution 2016-11 appointing Mr. Kepler as the designated agent. Mr. Hershey seconded the motion. MOTION CARRIED.

OXFORD REGIONAL PLANNING COMMITTEE

Mr. Brown reported that the last meeting was on March 23rd, at which time they discussed Armstrong Cable services and the rising costs. The members thought that if all of the municipalities went together they could possibly negotiate a better contract or get Verizon to have a contract as well. Also, Brandywine Conservancy received a grant to help with MS4 storm water regulations by coordinating with the Engineers and Roadmasters. The next meeting is April 27th. Mr. Kepler moved to approve the report. Mr. Hershey seconded the motion. MOTION CARRIED.

OLD BUSINESS

Backyard Chicken Ordinance – The Supervisors discussed the draft ordinance that was prepared by the Township Solicitor to allow for up to 12 hens on 2 acres. Mr. Jerry Iler was in the audience and questioned the line that said "residential district" as well as the section that said poultry are not allowed to run at large. Mr. Kepler questioned the allowance of geese because they are noisy. Mr. Brown wondered if turkeys should be included. Mrs. Jessie Clemens was in the audience and asked about peacocks being allowed. Mr. Kepler moved to send the draft ordinance to the Solicitor with the mentioned changes and have her send it to the planning commissions for comments and advertise for adoption. Mr. Brown seconded the motion. MOTION CARRIED.

NEW BUSINESS

2016 Road Project – Mr. Kepler moved to advertise the bids for the 2016 road project to be opened at the May IIth meeting at 8:00 p.m. Mr. Brown seconded the motion. MOTION CARRIED.

Route IO Sewer Lateral Connection Fee – Mr. Kepler moved to adopt Resolution 2016-10 establishing the lateral connection fee for the east side of Route IO to the public sewer line to be \$1,500.00. Mr. Brown seconded the motion. MOTION CARRIED.

OTHER BUSINESS

Complaint – Mr. Kepler discussed a complaint about dirt bikes riding in the field on a farm on Roney's Corner Rd. The neighbors' quality of life is being effected. Mr. Kepler spoke to the dirt bike riders and explained that the Township has an ordinance against disturbing the peace.
